The St. Marys Public Golf Course normally has a fleet of 20 golf carts available. It is the Tournament Coordinator's responsibility to call the clubhouse to reserve the carts 10-days in advance of the tournament. If additional carts are needed, the Tournament Coordinator may arrange to have carts brought to the golf course at their expense. There is an \$8 trail fee that applies to all outside golf carts used for a tournament.

A beverage cart will be made available on the course during the tournament for a \$50.00 fee. Only St. Marys Public Golf Course employees will be allowed to distribute beverages from this cart. The St. Marys Public Golf Course will provide its own driver(s), however, event photographers and support staff is able to ride along if desired. Additional beverage carts can be supplied for \$50.00 per cart per day.

The Tournament Coordinator will be responsible for obtaining all tournament prizes. The St. Marys Public Golf Course does not provide or distribute tournament prizes.

The Tournament Coordinator will be responsible for the participants to be properly attired. Proper attire is defined to be regular and customary apparel worn by golfers. Collared shirts are preferred for men. **Soft spikes are required.**

The Tournament Coordinator shall be responsible for any and all damages to any equipment, golf carts, or other property on the golf course. Also, please be aware that there is always a risk of vehicles being hit by golf balls parked at the clubhouse. Parking vehicles by the cart sheds is considered safer, but vehicles parked there may still be struck by a golf ball(s).

In the event of inclement weather and/or other uncontrollable events, the St. Marys Public Golf Course reserves the right to deal with each tournament as an independent event. The St. Marys Public Golf Course reserves the right to make "on the spot" judgment calls in dealing with the given situation. The Clubhouse Manager and/or golf course staff will make every effort to reschedule or rectify the situation in an equitable manner.

As the Tournament Coordinator, I agree to pay the \$150 lease hold payment at the time of reserving the golf course and agree to forfeit the lease hold payment (\$150) if notice of tournament cancellation is not given 72-hours prior to the scheduled tee time. I also agree to pay the balance due (listed above as the 'Total Cost') by the end of the above named tournament. Moreover, I also agree to purchase all beverages from the St. Marys Public Golf Course, I am aware that NO outside cereal malt beverages or alcoholic liquors are allowed to be brought onto (or taken off of) the St. Marys Public Golf Course property, and that violators of St. Marys City Code Chapter 3, Section 3-110.c will be prosecuted as per St. Marys City Code Chapter 1, Section 1-118.

I have read and agree to the cancellation policy and deposit requirement for my tournament. St. Marys Golf Course has the authority to charge my credit card if I do not cancel within the above stated time limits.

COURTESY RULES

Every golf course has rules. These are the rules of our course. We ask that you notify your golfers of these rules in advance so the day will go smoothly.

1. No cereal malt beverages or alcoholic liquor is allowed to be brought upon or removed from, the St. Marys Public Golf course.
2. All alcoholic liquor and/or cereal malt beverages consumed or possessed, on the St. Marys Public Golf Course, must be purchased through the club house.
3. The Tournament Coordinator will be responsible for the participants to be properly attired. Proper attire is defined to be regular and customary apparel worn by golfers. Collared shirts are preferred for men. **Soft spikes are required.**
4. Each golfer must have their own clubs.
5. The sponsors of the event will be responsible for the golf carts rented for their function. The Tournament Coordinator will be held responsible for the misuse of the golf carts, damage to the property, or related injuries.
6. Respect for the course, fellow golfers, and employees, is required by all players. We expect standard golf course etiquette at all times so that everyone can enjoy their round of golf.
7. Replace the flagstick carefully in an upright position.
8. Please keep your cart 30' from the greens and tees.
9. **PLEASE REPAIR ALL BALL MARKS** and replace divots in fairway and smooth out footprints in the bunkers.
10. ALWAYS rake a bunker after you have played from it.
