

RESOLUTION NO. 06-19 PUBLIC PROPERTY FEE RESOLUTION

A RESOLUTION ESTABLISHING FEES FOR THE SWIMMING POOL, GOLF COURSE, RECREATION PROGRAM, CAMPER PADS, ARMORY, AND GAZEBO, FOR THE CITY OF ST. MARYS, KANSAS.

WHEREAS, the City of St. Marys charges for certain activities and facilities, and needs to review the aforementioned from time-to-time, in order to help offset the expense of providing such amenities; and

NOW, THEREFORE BE IT RESOLVED, by the governing body of the City of St. Marys that this fee and rate schedule is established:

Section 1. Swimming Pool Rates:

- a) Season Pass:
 - 1) Family (full-time students to age 22).....\$100.00
 - 2) Adult (18 and over).....\$ 55.00
 - 3) Student (17 and under).....\$ 45.00

- b) Daily Pass:
 - 1) Adult (18 and over)\$3.00
 - 2) Student (ages 7 to 17)\$2.00
 - 3) Child (ages 3 to 6).....\$1.00
 - 4) Infant/Toddler (age 2 and under)FREE
 - 5) Water Exercise\$3.00

- c) Group Parties:
 - 1) Minimum fee (up to 20 guests).....\$65.00
 - 2) Additional fee per person (groups of 20 or more)\$ 2.00

- d) Group Lessons (per session):
 - 1) City resident\$40.00
 - 2) Non-resident.....\$45.00

Section 2. Golf Course Rates:

- a) Season Pass:
 - 1) Family (full-time students to age 22).....\$375.00
 - 2) Single (age 18 and over)\$300.00
 - 3) Senior Single (age 60 and over).....\$275.00
 - 4) Senior Couple (age 60 and over)\$325.00
 - 5) College Student and younger\$150.00

 - 5) Non-refundable (Date Saver) deposit\$ 150.00
- d) Daily Cart Path (using their own cart/not renting cart shed)\$ 8.00
- e) Annual Cart Path:(using their own cart/not renting cart shed) ...\$ 55.00
- f) Cart Shed and Cart Path:
 - 1) Gas Cart \$250.00
 - 2) Electric Cart \$275.00
- g) Cart Rental Fees:
 - 1) Nine (9) holes..... \$ 11.50
 - 2) Eighteen (18) holes \$ 21.00
- h) Reserved for future use.
- i) Special Promotion or Event Rates or Discounts: with the prior approval of the City Commission, the Golf Course Advisory Board may offer rates or discounts that vary from the above stated golf course rates. The Special Rates or Discounts shall be prominently displayed in the Club House.

Section 3. On Season Club House Rental (March 1 to October 31st):

- a) Minimum rental fee of \$50.00 for the first hour, plus \$15.00 per hour for each additional hour for the use of the club house upstairs.
- b) A security deposit of \$250.00 is required.

Section 4. Off Season Club House Rental (November 1 to February 28):

Section 5. Camper Pad Rental Fees:

- a) \$10.00 per day shall be assessed for rental of camper pads in Riverside Park not to exceed five consecutive days without prior approval of the city manager. This fee is all inclusive of electricity, water and the disposal of sewage at the wastewater treatment plant.

 - 4) Three Day Access\$350.00
 - 5) Each additional consecutive day\$150.00
 - 6) Weekday Event-Hourly (3-month minimum).....\$ 20.00
 - 7) Hourly (weekdays only – no alcohol).....\$ 40.00
- c) Alcohol Available:
 - 1) Security Deposit.....\$1000.00
 - 2) Single Day Access (6:00 AM – Midnight)\$ 250.00
 - 3) Two Day Access:\$ 325.00
 - 4) Three Day Access\$ 400.00
 - 5) Each additional consecutive day\$ 200.00
 - 6) Weekday Event-Hourly (3-month minimum).....\$ N/A
 - 7) Hourly (weekdays only – no alcohol).....\$ N/A

 - 1) Security Deposit.....\$150.00

Section 7. Gazebo (Riverside Park):

- a) The gazebo will be rented at the rate of \$50.00 per day.
- b) Damage/Clean-up Deposit of \$250.00 per rented event.

 - 1) One Day (6:00 a.m. until 10:00 p.m.).....\$165
 - 2) Two consecutive days (6:00 a.m. until 10:00 p.m. each day).....\$225
 - 3) Field rental fees for tournaments and events for fundraisers and non-profits may be waived with City Commission approval.
 - 4) The city recreation program and local schools have first priority for all diamonds/fields during their seasons. Afterwards Diamonds #1 through #5/the soccer field may be reserved for \$15-per hour. If Diamonds #1 through #5/the soccer field are not reserved, and not undergoing maintenance, they are open to local residents on a first-come first-served basis for no cost. Batting cages are included in field rentals.
