## ATV/UTV/Golf Cart Registration Application

The operation of all-terrain vehicles (ATV), utility type vehicles (UTV) and Golf Carts on the streets of St Marys is governed by Kansas State Statutes as well as the ordinances of the City of St Marys.

Operators must be at least 16 years-of-age and have a valid driver's license. Anyone 17 years-of-age and under are required to wear a DOT approved helmet while operating any ATV or UTV.

At the time of registration the owner shall provide proof of insurance for the vehicle being registered. The insurance must be for the registration period of one year (1 January – 31 December). Insurance that expires or the owner cancelling the insurance during the registration period will result in the registration being revoked and a new registration application applied for with the costs being applied. Insurance must list the vehicle that is insured, by description or by model and VIN/Serial number.

All persons are required to wear eye protection, except when the ATV, UTV or Golf Cart has a DOT approved windshield.

When operating an ATV, UTV or Golf Cart the operator will obey all rules of the road that are listed in state statute or city ordinances.

Vehicles must remain on city streets / alleys at all times, unless to cross a US or State Highway.

ATVs, UTVs and Golf Carts will not be operated on any seeded area, unless the property is owned by the operator or has permission of the property owner.

Once the vehicle is registered a City Sticker will be issued. The sticker must be placed on the left side of the ATV, UTV or Golf Cart so it is visible at all times. A business that deals in the repair or sales of ATVs, UTVs and/or Golf Carts at the discretion of the Chief of Police may affix the sticker so it can be removed and used on different vehicles for the purpose of test drives.

Upon registration you will be provided a copy of the registration certificate. This copy along with proof of liability insurance must be kept on the vehicle and presented to law enforcement upon request. This registration is valid only within the city limits of St Marys, Kansas.

ATVs, UTVs and Golf Carts shall be operated only during the hours of ½ hour after sunrise and ½ hour before sunset unless equipped with lights as required by law for motorcycles or any other motorized vehicle.

ATV's, UTV's and Golf Carts shall not be parked on city streets for any extended period of time.

No person riding upon any ATV, UTV or Golf Cart shall attach the same, himself or herself to any vehicle upon a roadway.

ATV's, UTV's and Golf Carts shall not carry more persons at one time than the number for which it is designed and equipped. A person propelling an ATV, UTV or Golf Cart shall not ride other than upon or astride a permanent and regular seat attached thereto.

No person operating an ATV or UTV shall carry any package, bundle or article which prevents the driver from keeping their hands upon the handlebars.

By making this application, you, the vehicle owner are acknowledging that you have read the appropriate State Statutes and City Ordinances relating to the use of ATV's, UTV's and Golf Carts on City streets.
